

**SERVICE CONTRACT**

**Hasanova Nargiz Elmar** (hereinafter referred to as “**Customer**”), **Director of “Sharaf Media” LLC** acting on the basis of the legislation of the Republic of Azerbaijan and its Charter on one hand and on the other hand, physical person **Majidov Rashad Ali** (hereinafter referred to as “**Contractor**”) acting on the basis of the legislation of the Republic of Azerbaijan, have concluded this Contract (hereinafter referred to as “**Contract**”) as follows.

**I. SUBJECT OF THE CONTRACT**

1.1 According to this contract, at the request of the “**Customer**“, the “**Contractor**” undertakes to provide a service determined with Appendixes that are integral part hereof, and the “**Customer**” undertakes to accept it and pay the “**Contractor**” an amount determined with the Contract for it .

**II. OBLIGATIONS OF THE CONTRACTOR**

2.1 At the request of orders submitted by the “**Customer**”, the “**Contractor**” has the following obligations:

1. to write and post articles on Service Sites.

**III. OBLIGATIONS OF THE CUSTOMER**

3.1. The “**Customer**” has the following obligations:

- 3.1.1. to provide the necessary information (technical indicators, images, description of the provided services, etc.) to the Contractor for creating an advertisement on the Internet page;
- 3.1.2. to formalize the nature of the services in the form of a Technical assignment;
- 3.1.2. to pay the total cost of services on time;
- 3.1.3. to submit relevant documents to the "Contractor", if obtaining a special permit (license) and (or) certification of the goods (service) is required by legislation to carry out the type of advertising activity.

**IV. SERVICE PRICE AND SETTLEMENT**

- 4.1. The “**Customer**” shall pay the value of services provided under this Contract for 10 (ten) calendar days starting from the validity of this Contract.
- 4.2. The payment shall be made through bank transfer.

**V. RESPONSIBILITY OF THE PARTIES**

- 5.1. The “**Customer**” is responsible according to the legislation of the Republic of Azerbaijan for the content of the information provided for placing the advertisement on the website.
- 5.2. The "Contractor" is not responsible for the correctness of the information provided by the "Customer" in the compilation of the advertisement posted on the website.
- 5.3. The occurrence of force majeure causes the extension of the contract's performance period to the period of their occurrence.

5.4. This Contract is drawn up in two copies and comes into force on the date of signing by the parties. This Contract shall remain in force until the parties have fully performed their obligations.

5.5. All disputes and disagreements arising between the parties arising from this Contract shall be resolved by mutual agreement.

5.6. If an agreement is not reached, the Parties apply to the relevant court of the Republic of Azerbaijan for the resolution of the dispute.

5.7. All additions and changes to this Contract are valid if approved in writing between the Parties.

## VI. CONTRACT DURATION, VALIDITY TERM AND TERMINATION

6.1. This Contract comes into force from its signing.

6.2. This Contract remains in force for 1(one) year.

6.3. Either Party may terminate this Contract by giving 2 (two) business days prior written notice to the other Party. Such termination shall not affect the performance of outstanding obligations between the Parties.

## VII. GENERAL TERMS AND CONDITIONS

7.1. The Contract is signed in 2 (two) original copies, drawn up in the Azerbaijani language, and both have the same legal force.

7.2. Any changes and additions to this Contract enter into legal force only with the signature and approval of the legal representatives of the Parties in writing.

7.3. Neither party may assign its rights and obligations under this Contract to a third party without the consent of the other party.

7.4 The Contractor is responsible for the confidentiality and security of all customer information.
